

SEAL REPLACEMENT INSTRUCTIONS

- 1. Remove acme gasket, fill adapter, poppet, valve spring and gasket and discard.
- 2. Inspect seal surface and threads. If either threads or sealing surface is damaged or defaced, entire valve must be taken out of service and replaced.
- 3. Install valve spring on poppet and install into valve body and into guide.
- 4. Install gasket on shoulder of valve body.
- 5. Apply high strength thread locker to exterior threads of fill adapter and tighten into body.
- 6. Install acme gasket into fill adapter groove as shown.
- 7. Connect the valve assembly outlet to a pressure source of at least 150 PSI. Check for leaks (as evidenced by bubbles) at all joints and sealing surfaces by submersing the valve in water, or using a suitable leak detector solution such as "Marshall Excelsior" leak detector.

CAUTION: DO NOT USE THE VALVE IF ANY JOINT OR SEALING SURFACE CONTINUES TO LEAK UNDER PRESSURE.

Relieve all pressure from system before removing filling connector, then release lever lock and lift lever to vertical (valve open) position. Remove entire valve from line before performing repairs.

To prevent exposure of NH $_3$ or LP-Gas to people and livestock, release these chemicals outdoors in air currents that will ensure dispersion. Keep LP-Gas far enough from any open flame or other source of ignition to prevent fire or explosion! LP-Gas is heavier than air and may not disperse or evaporate quickly if released in still air.

Disassembly and Repair Procedure

CAUTION: READ AND UNDERSTAND ALL INSTRUCTIONS, INCLUDING THE NOTICE AND WARNINGS ON THIS SHEET, PRIOR TO ANY DISASSEMBLY OR REPAIR

NOTE: Perform repairs in a clean environment. To prevent contamination of component parts and valves, make sure hands, clothing, tools and work areas are clean of oil, grease and other foreign matter.

Thoroughly examine valve handle and all associated parts for excessive wear and proper function before making repairs. Check ACME threads for excessive wear and damage. Check for a smooth surface on the filling connector that seats on the filler valve gasket when the valve is used. Replace any components not in good condition and fully operational.

NOTICE

LP-Gas is extremely flammable and explosive. Failure to install parts exactly as described in the instructions could result in a poorly performing product. Marshall Excelsior Company warrants its products and repair kits to be free from defects in materials and workmanship under normal use and service for twelve (12) months from the date of installation or eighteen (18) months from the date of shipment from the factory, whichever is earlier. If within thirty (30) days after buyer's discovery of what buyer believes is a defect, buyer notifies Marshall Excelsior Company thereof in writing, Marshall Excelsior Company, at its option, and within thirty (30) days, will repair, replace, or refund the purchase price of that part or product found by it to be defective. Failure of buyer to give such written notice shall be deemed an absolute and unconditional waiver of any and all claims of buyer arising out of such defect.
